Ana Cordeiro Santos is a researcher at the Centre for Social Studies of the University of Coimbra, where she is a member of the Study Centre on Science, Economy and Society. Her research work is focused on the topics of financialization, household indebtedness and housing. Ana has published various academic papers on these topics in national and international scientific publications. Such as her recently coordinated collective work “The new issue of housing in Portugal: An approach to political economy by Editora Conjuntura Actual

(2019)”.



Barbara Steenbergen has been working for the protection of tenants for more than 18 years. She started in 2001 as head of the president’s office of the German Union of Tenants (Deutscher Mieterbund), Berlin and as political coordinator for energy policy and international affairs. In 2007 she was elected as head of the IUT EU Office in Brussels. Since 2013 she has been

member of the IUT Executive Committee. She is responsible for the political relations and the lobbying towards the EU Commission, the EU Parliament and the EU Council. Since 2016 she is also member of the EU Urban Agenda Partnership for Housing. Barbara Steenbergen is chairing the stakeholder forum of the “European Responsible Housing Initiative” and the jury of the “European Responsible Housing Awards”.



Georgia Alexandri is holding a postdoctoral Marie Curie fellowship for which she is working on her current project. The aim of the project is to identify structural drivers of post-crisis urban transformations in Southern European cities by comparing Athens and Barcelona. 

Karin Zauner-Lohmeyer is Spokeswoman of the European Citizens' Initiative „Housing For All“. Born on the 12th of November 1978 in Bruck an der Mur, she grew up in Mariazell in Styria, lives and works in Vienna. She is forester, journalist and doctor of media studies and has been working for more than 18 years in the Vienna City Administration - first in the forestry office, then in the cities' press department and, since 2012, in the municipal

housing company „Wiener Wohnen“. She is head of the department "Social Management" and occupied with the housing needs of tenants in municipal housing, eviction prevention, social research, exchange of knowledge on European level and generally with developments on housing markets. As a private person, she launched the European Citizens' Initiative "Housing for All" with like-minded allies from all over Europe on the 18th of March 2019. She demands better EU legislation for more public investments in affordable, public and social housing. She is deeply convinced that housing is a basic need and a human right – and not a commodity.



Luís Mendes has a degree in Geography and a master's degree in urban studies. He is a guest assistant at the Escola Superior de Educação de Lisboa and at the Instituto de Geografia e Ordenamento do Território da Universidade de Lisboa (IGOT-UL). Since 2003, he has been a permanent researcher at IGOT-UL's Centro de Estudos Geográficos da Universidade de Lisboa (CEG/UL), where he has developed research in the fields of Urban Studies (namely in gentrification and urban

Ricardo Barranco is a Data Scientist and GIS Expert for the Joint Research Centre of the European Commission in Ispra, Italy. His main fields lay within the research and development of urban indicators in EU cities. He started his academic career with a master's degree in Environmental Engineering and published various academic papers about urban and rural regions in Europe. He is an expert of the "CiTown project" which looks at the financialisation and housing costs in several European cities and is the first report on the topic of financialisation of housing of the European Commission. Ricardo Barranco is also a core member of the LUISA

Territorial Modelling Platform, a platform of the European Commission which is primarily used for the ex-ante evaluation of EC policies that have a direct or indirect territorial impact.
